What is this product?

Type: Stonewood Global Cautious Fund Class A is a class of Stonewood Global Cautious Fund ("Fund"), a cell of Stonewood Global Fund PCC Limited, which is an open-ended collective investment scheme, constituted as a protected cell company under the Companies (Guernsey) Law, 2008, as amended, registered with limited liability with registration number 59227. The Fund is only available to qualified investors. The Fund is not available to US Persons and US based investors.

Objectives: The Product targets a net return of 4% per annum. The Product seeks to balance appreciation of capital, income generation and risk of loss to provide capital growth whilst focussing on capital preservation over the short to medium term with a global diversified portfolio of equities, fixed income securities, listed real estate and commodity linked instruments. The Product has a Benchmark return consisting of 20% MSCI World Total Return Index and 80% Bloomberg Barclays Global Aggregate Bond Index. The Product seeks to achieve income and/or capital returns through a fully flexible portfolio comprising approximately 15% to 25% equities and the balance in bonds and other securities.

Intended retail investor: The Product is suitable for investors who are seeking income with some capital growth whilst focusing on preservation of capital by holding a diversified global portfolio of equities, fixed income securities, listed real estate and commodity linked instruments. Investors should have a low risk level, tolerate a low level of volatility in the value of their investment and preferably have an investment time horizon of at least 3 years. Investors should be able to evaluate the risks and strategy of investing in the Product and to bear the economic consequences of investment in the Product including the possibility of any loss arising from the investment. Further, the Product is only suitable for investors who are able to make a minimum investment of US\$100,000.

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the Product for 3 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of the Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the market or because we are not able

to pay you. We have classified this Product as 3 out of 7, which is a medium-low risk class. How long should I hold it, and can I take money out early?

Recommended Holding Period (RHP): 3 years.

An investor can only seek a redemption on the Redemption Dealing Day which is every Thursday, or if not a Business Day on the Business Day immediately following. Redemptions are subject to a notice period. Redemption Notices are to be received by 4 pm (Guernsey Time) on the Business Day prior to a Redemption Dealing Day. If a Redemption Notice is received after the deadline, it will be treated as a request for redemption on the next relevant Redemption Dealing Day, unless the Administrator agrees otherwise in any particular case. The minimum redemption amount is \$10,000. The Manager reserves the right to enact a compulsory redemption, the Compulsory Redemption Amount is US\$100,000 or less per Dealing Day until the holding has been completely redeemed. There are no redemption or exit fees.

How can I complain?

As a shareholder of the Fund you do not have a right to complain to the Channel Islands Financial Ombudsman (CIFO) about the management of the Fund.
